Introduction to E-Tax





How do I access E-Tax?

- There will be a hot button on the IRD website (<u>www.ird.gov.sb</u>) which will take you directly to the E-Tax home, after implementation.
- The direct website address is https://etax.ird.gov.sb



- 1. Click on the "Register Now" button.
- Enter your full name, business name, email address, contact phone number, user name and Tax Identification Number (TIN).
- Message: "Submission of registration successful".

<u>Note</u>: A TIN is required to be an E-Tax user.
