TAX COMMISSIONER ANNOUNCES TAX AGENT PROGRAMME A SUCCESS

The Commissioner of Inland Revenue, Mr Joseph Dokekana, has announced that the tax agent programme that came into effect on 1 January 2023 is meeting its objectives. So far 15 tax agents have been registered with the Inland Revenue Department, receiving their Registration Certificates.

The registration process protects members of the business community and other taxpayers by ensuring that persons who act on their behalf in tax matters have the required skills and test of character to do so. To become registered, the agent must be a member of the Institute of Solomon Islands Accountants (ISIA), have no criminal record, not be bankrupt or in government employment, and meet other requirements.

"This new registration ensures that taxpayers receive the highest standard of service in relation to their tax matters," said Mr Dokekana. "It increases trust between the government service and the taxpaying community."

Income tax returns are due to be lodged with the IRD by the end of March for those taxpayers with a tax year ending 31 December. Those tax returns filed by persons calling themselves "tax agents", but who are not registered with IRD, will not be accepted by IRD.

It is an offence to charge a fee to prepare a return or otherwise act on behalf of someone else, unless the person is a registered tax agent. The tax agent will display their registration certificate in a prominent place in their office.
